**WAIVER**

In consideration of your acceptance of my application for participation in the Chicken Joe's Ride for Kids Inc. Tour , I the undersigned, for myself, my heirs, executors, administrators and assigns, waive and release any and all claims for damages, for death, personal injury or loss of property, I may have or which may accrue to me as a result of my participation in the Chicken Joe's Ride for Kids Inc. Bike Tour. I, the undersigned, discharge and release Chicken Joe's Ride for Kids Inc. and all other sponsoring agencies, governmental entities, businesses and organizations, and their respective agents, boards, trustees, directors, officers, subsidiaries, affiliates, parent companies, commissions and any other involved municipalities, and employees and representatives of the foregoing, from all liability arising out of or connected in any way with my participation in this event, whether or not caused by the negligence of any of the above parties.

I acknowledge that the Chicken Joe's Ride for Kids Inc. contains risks, including the risks of falling, collision with other bicyclists, motor vehicles, or stationary objects, and the conditions of the road. My participation is voluntary and done at my own risk. I voluntarily assume all risks of loss, damage or injury that may be sustained while participating in this event. I attest that I am sufficiently trained for the completion of this event, recognize that an event of this nature can be physically demanding.

I acknowledge the sponsor's recommendation that I consult with a physician regarding the advisability of my participation in this activity. I understand and agree that medical or other services rendered to me by or at the insistence of any of the above parties is not an admission of liability to provide or to continue to provide any such services, and is not a waiver by any of said parties of any right hereunder. I understand that serious accidents occasionally occur during the Chicken Joe's Ride for Kids Inc. Bike Tour, and that participants in this event may sustain mortal or serious injury as a consequence thereof. Nevertheless, I agree to assume these risks and to release and hold harmless all of the persons mentioned above who might otherwise be liable to me for damages.

I grant to the Chicken Joe's Ride for Kids Inc. Bike Tour Physician Medical Director and his designee access to my medical records and physicians relating to the medical care that may be administered to me as a result of my participation in the Chicken Joe's Ride for Kids Inc. Bike Tour. I attest that the equipment that I will use in this event is in good mechanical condition. I understand that bicycle helmets can prevent serious injury and I agree to wear one while participating in this event. I agree to wear the 2009 rider vest to identify myself as a registered participant. I agree to abide by the rules of the event as established by the promoting organization and to obey the directions of the officials. I voluntarily sign this agreement.
